

## Superior Court of California, County of Sacramento RESET Program PARTICIPANT CONDITIONS

I understand that the validity of my participation in this program is conditioned upon my eligibility for the RESET Court Program. If at any time after my entry into this program, it is discovered that I am, in fact, ineligible to participate in the program or have violated the terms of my RESET Court contract, I may be immediately terminated from the program and face probation/mandatory supervision/PRCS or parole violation proceedings.

## CONDITIONS

- 1. Obey all Laws
- 2. Advise the Court and the Program Provider of your place of residence at all times and immediately report any change of address and/or phone number.
- 3. Do not loiter, for the purpose of soliciting an act of prostitution or lewd sexual activity within 1000 feet of the following areas:

(a) Edison Ave from Auburn Blvd. to Watt Ave.

(b) Auburn Blvd. from Marconi Ave. to Winding Way.

(c ) Del Paso Blvd from Globe Ave. to Marysville Blvd.

(d) El Camino Ave. from Colfax St. to Taft St.

(e) Rio Linda Blvd. from Del Paso Blvd to Grand Ave.

(f) Area bound by 14th to 21st Streets from C to S Streets

- (g) Broadway from Hwy 99 to Stockton Blvd.
- (h) Stockton Blvd. From 2nd Ave. to Victory Ave.

- (i) Madison Ave. from Date Ave. to Roseville Rd.
- (j) Hillsdale Dr. from Walerga Rd. to Tressler Ave.

(k) Watt Ave. from Roseville Rd. to Edison Ave. and in W. Sacramento.

- (I) West Capitol Ave. from 3rd St. to I-80 onramp.
- (m) Merkely Ave. from W. Capitol Ave. to Sycamore.
- (n) Harbor Blvd. From Reed Ave. to Industrial Blvd.
- (o) Fifth St. from C St. to W. Capitol Ave.
- (p) Third St. from C St. to W. Capitol Ave.
- (q) Jefferson Blvd. From Sacramento Ave. to 15th St.
- (r) Westacre Rd. from Michigan Blvd. to Evergreen St.
- 4. Do not post online or any social media ads for offers of prostitution.
- 5. Comply with treatment plan as developed with program provider, as required.
- 6. Participate in all individual and group therapy sessions developed with program provider, as required.
- 7. Complete 8 week course with provider, including all program requirements.

## PARTICIPATION AFFIRMATION

I understand that participation in RESET Court is a privilege, not a right, and that it is a great opportunity to obtain information, skills, services, and associations to help me change my life and fulfill my potential. I promise to give RESET Court my honest and best efforts.

Failure to comply with all conditions during the diversion period may result in the court ordering that I be deleted from RESET court and the intended sentence agreed to in the plea bargain imposed.
