The Court applied for and was awarded grant funding under the Federal Access to Visitation Grant Program.

With these funds, the Court is collaborating with four (4) local providers of supervised visitation and safe-exchange services to provide services to eligible, low income, non-custodial parents who have been ordered by the Family Relations Court to use supervised visitation and safe exchange services under the Family Code.

To be eligible for grant funding, recipients must present providers with a signed supervised visitation order on the mandatory Judicial Council forms, FL-341(a) [Supervised Visitation Order] or DV-150 [Supervised Visitation Order – Domestic Violence Prevention].
