### Remote Appearances for Family Law and Probate Court Proceedings

#### Process

##### Parties and attorneys may ask for a remote appearance

- ✓ As soon as possible before the court proceeding, you should file and serve form [Notice of Remote Appearance \(RA-010\)](#).
- ✓ As soon as possible before the court proceeding, if you oppose a party or attorney appearing remotely at trial or witness at trial, or contempt, default judgment, domestic violence or elder abuse restraining order, or termination of parental rights proceedings, file and serve [Opposition to Remote Proceeding At Evidentiary Hearing or Trial \(RA-015\)](#).
- ✓ The Court will make an [Order Regarding Remote Appearance \(RA-020\)](#) on the opposition to remote appearance. If no order on the opposition is received in advance, the order will be stated at the trial.
