11 **ORDER**

12 **IMPLEMENTATION OF EMERGENCY RELIEF**

13 (Cal. Gov. Code §68115)

14 Pursuant to the authority granted by order of the Chief Justice of the California Supreme
15 Court as Chairperson of the Judicial Council dated August 17, 2020, and upon the grounds
16 specified in California Government Code section 68115,

17 **IT IS HEREBY ORDERED,**

18 1. This Court may hold sessions anywhere in the county, including in correctional
19 and juvenile detention facilities, from August 23, 2020, to September 21, 2020, inclusive (Gov.
20 Code, § 68115(a)(1));

21 2. Except as to filing types expressly excluded from the filing holiday by prior
22 separate court orders [consult the Court's public website for all prior orders excepting specified
23 filing types from the filing holiday], the court declares that from August 10, 2020 to September 8,
24 2020, inclusive, is deemed a holiday for purposes of computing the time for filing all other papers
25 with the court under Code of Civil Procedure sections 12 and 12a. The court makes this
26 declaration because the emergency conditions attendant to the Covid-19 pandemic shall continue
27 to substantially interfere with the public's ability to file and process papers falling within the
28 holiday at the court's facilities during that period. (Gov. Code, § 68115(a)(4));

1 3. The Court declares that from August 17, 2020 to September 15, 2020, inclusive, be
2 deemed holidays for purposes of computing time under Welfare and Institutions Code sections
3 632 and 657, if the above-described emergency conditions prevent the Court from conducting
4 proceedings or accepting filings as necessary to satisfy these deadlines on those dates (Gov.
5 Code, § 68115(a)(5));

6 4. The Court extends the time period provided in section 825 of the Penal Code
7 within which a defendant charged with a felony offense must be taken before a magistrate from
8 48 hours to not more than 7 days, applicable only to cases in which the statutory deadline
9 otherwise would expire from August 14, 2020 to September 12, 2020, inclusive (Gov. Code, §
10 68115(a)(8));

11 5. The Court extends the time period provided in section 1382 of the Penal Code for
12 the holding of a criminal trial by not more than an additional 30 days, applicable only to cases in
13 which the original or previously extended statutory deadline otherwise would expire from August
14 19, 2020 through September 19, 2020, inclusive. (Gov. Code, § 68115(a)(10); Executive Order
15 N-38-20 (03-27-20));

16 6. The Court extends the time period provided in section 334 of the Welfare and
17 Institutions Code within which a hearing on a juvenile dependency petition must be held by not
18 more than 15 days, applicable only to minors for whom the statutory deadline otherwise would
19 expire from August 17, 2020 to September 15, 2020, inclusive (Gov. Code, § 68115(a)(12)); and

20 7. The Court extends the time period provided in section 657 of the Welfare and
21 Institutions Code within which a hearing on a wardship petition for a minor charged with a felony
22 offense must be held by not more than 15 days, applicable only to minors for whom the statutory
23 deadline otherwise would expire from August 17, 2020 to September 15, 2020, inclusive (Gov.
24 Code, § 68115(a)(12)).
